A. Product Recommendations for July

 <u>Budgets/Cashflow Forecasts</u> – July is an appropriate time for the preparation of Budgets and Cashflow Forecasts for your clients.

Within the ESS BIZTOOLS' product packages you have information relating to the preparation of Budgets and Cashflow Forecasts. These packages also refer to the arrangement that we have with "Plan Guru".

• <u>Improving Debtors' Days Outstanding</u> – our suggestion is that, for every business client who is offering credit, you ensure that their "debtors' days outstanding" is calculated each time you come into contact with the client.

If debtors' days outstanding is higher than 40 days, we suggest you have a conversation with your client in relation to your firm undertaking a "Debtors' Days Outstanding Review" in an attempt to reduce the investment that your client has in sundry debtors.

Within the Debtors' Package you will see details of the arrangement that ESS BIZTOOLS has negotiated with IODM; if you wish to refer any of your clients to IODM.

• <u>Identifying Grants for Individual Clients</u> – if you have not been in the habit of preparing a grant report, as part of the annual accounts preparation process, July can be a good time to undertake a review of each business client to identify if they are potentially eligible for government grants.

To enter the basic profile will take approximately three minutes. To review the preliminary list of grants available and answer the supplementary questions will normally take a member of your team, with good knowledge of the client, 10 to 12 minutes.

By being proactive in the identification of government grants, you will find that this can lead to significant other work relative to business plans, budgets and cashflow forecasts, corporate governance reviews and other activities that are being financed to approximately 50% by a government grant.

 <u>Collaboration Grants Available for Clients in the Mining Equipment Technology and</u> <u>Services Industry</u> – the mining equipment industry is one of the government's "Industry Growth Centres". The government has encouraged that industry to incorporate a special company which operates as the "industry's representative" – METS Ignited Australia Ltd, in identifying small/medium enterprises, larger businesses, original equipment manufacturers and, in some instances, mining companies, that might be interested in collaborating on a project that could ultimately benefit the mining equipment technology and services industry.

Grants of a minimum of \$100,000 to a maximum of \$3M, are available for the "collaborating entities" on a 50% funding basis. The funds are to be expended over a two-year period.

The funding round that is currently underway closes on 31st July 2017. A summary of this grant is available in Paper 014-169.
