C. ESIC Update

We have included some new material within the ESIC Product Package, primarily to assist you if you are representing a client who is dealing with you via internet or Skype. If you have any questions or comments on the ESIC Product Package, can you please contact us?

We have also developed a client checklist that you might like to hand out at a seminar or send to participants in a webinar that you are conducting to give them more involvement in the review of the requirements to be an ESIC. There is also a section for investors to give them a brief overview of the benefits that are available for investors in an ESIC.

There was an article in the Financial Review last week relating to a Perth company's (Epic Delivery) difficulties with satisfying the ESIC's Principles Based Test with the Australian Taxation Office. These difficulties highlight the very important role for proactive accountants to play in the ESIC assessment process.

According to the Financial Review, Epic Delivery requested the ATO to conduct an assessment review of the company after it was apparent that the company could not accumulate 100 points under the Gateway Test.

According to Epic Delivery's co-founder, the company had difficulty in convincing the ATO that the company had a "sufficient sustainable competitive advantage". The Epic Delivery co-founder said that after a barrage of questions, 9 ot 10 emails with a stack of questions in each, they finally convinced the ATO that the company fitted the ESIC description.

We believe that the recent amendments we've made to the ESIC Product Package will assist you to be able to conduct the due diligence review with a minimal amount of interaction with the Australian Taxation Office.

Epic Delivery's experience highlights the significant benefits for a company that has retained a proactive accountant who is specialising in ESIC Due Diligence Reviews to assist that company through this process.
